President's Letter

As I begin this letter, it is night time and it is still 60+. Spring is here! Hummingbirds are in the area, trillium is everywhere and the sweet cherry trees are laden with blossoms. What a beautiful area!!

The Board has spent many hours working with our attorney and other concerned folks in the area to reduce any potential negative impact from the condominiums and dockage planned for the Narrows. We feel the condominium, per se, is a suitable use of this commercially zoned property and it appears the developer has appropriate plans for handling water runoff to preclude significant impact on the Narrows and Lake Leelanau. The Board still feels that of the 8 slips presently permitted, only 4 are marginally deep enough to be truly useful without destroying bottom vegetation, etc. Thus, the present dockage allocation is a compromise and offers considerably less potential environmental damage than that originally proposed.



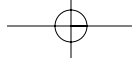
One very positive outgrowth of this issue are the various activities around the lake to update/upgrade the township zoning ordinances that impact shoreline activities(see related story on page 2). All members should be alert to shoreline activities of a questionable nature and are encouraged to get involved with zoning issues. 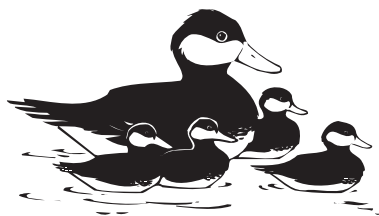

Leland Township Planning Commission approves amendment to common use waterfront (Keyholing) ordinance

At a meeting on May 22, 2007, the Leland Township Planning Commission voted six to one to amend section 18.23 of the township zoning ordinance to eliminate the words "without residing upon said frontage". This change effectively removes a loophole in the ordinance that formerly allowed families who share use and/or ownership of waterfront property, and reside on the property, to be exempt from the important regulations contained in the ordinance. Before this change developers could conceivably take advantage of this loophole to build multi-family housing with unregulated dockage along the shores of the lake without complying with any of the conditions contained in Sec. 18.23. These regulations, which now effect all multi-family users/owners of shoreline lots, whether they reside upon them or not, cover many important issues including the amount of frontage and square footage required for each family having water front privileges, the number and size of docks permitted (one per 100 feet), the parking required, and additional conditions required for site plan review.

The Lake Leelanau Lake Association requested this amendment several months ago and we are pleased that the Planning Commission has taken this important step to insure that in the future we will have responsible regulation of shoreline development around North Lake Leelanau.

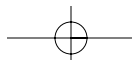
LEGACY CIRCLE CELEBRATION - SAVE THE DATE!

The Warden's Point cottage was built circa 1907 and has five separate buildings, main house, ice house, pump house, and carriage house on three acres with 360 feet of Lake Leelanau frontage. All of the first floor walls and ceilings are paneled with "wild cherry" and maple. The second floor is also wood paneled. Most of the furniture in the cottage is original. It was once considered "catalog furniture" but time has turned it into antiques and collectors' items. The outside stones were gathered from local fields. The cottage faces west for beautiful sunsets and views of Whaleback.

Lake Leelanau Watershed Management Regulatory Codes

The Lake Leelanau watershed crosses over the political jurisdictions of ten townships, three villages and three counties. Each of these jurisdictions enforces various regulations such as land use, drainage, soil erosion, and building codes. In addition, the State of Michigan and the United States hold authority over the use and treatment of wetlands and shorelines, pesticide application, water quality and air quality.

Americans strongly dislike being told what they can and cannot do with their land. On the other hand, we also believe that we have the right to protect our land, water, and related interests from the folly of our neighbors. Throughout our history, we have fought battles on the field and in the courtroom to determine the limits and extent of the rights of landowners and their use of the land and water.

Land use regulations attempt to balance these rights and protections. Although at first glance they may appear as obstacles to progress – in reality they are formulas for the best way to progress without compromising the quality of life. The regulations evolve and, hopefully, improve as we learn more about planning and the relationship of humans to the natural world.

The array of regulations and overlapping jurisdictions can be quite confusing at first glance and the process of securing permits for a project can be frustrating. Nevertheless, there is method behind the madness. Remember, the types of permits you require depend on the type of project you plan. The agency personnel who process your permits are there to advise you on the safest way to proceed. You may have to consider some alternative ideas so keep an open mind!

Whatever you intend to do, there are a host of sources for advice and information. This issue offers information on where to go for permits and an overview of the Leelanau Conservation District Office. Leelanau Conservation District Overview

Leelanau Conservation District has been working with landowners since 1943. Started initially to work with farmers wishing to apply various soil and water conservation practices, the District now works more actively with the non-farming community.

The goal of soil and water conservation has not changed, but as farmers became more skilled and as land has become more divided into smaller parcels, the District began to teach these new owners the importance of protecting both surface and groundwater quality from degradation. It also became apparent that residential development, whether large or small, was creating some serious soil erosion problems and destroying far too many woodland acres, and again the District was there to help solve problems and restore natural resources.

Highly trained staff members include two erosion control specialists, a forester, a native plant specialist, and a USDA District Conservationist. Staff members are cross-trained to provide better service to the public.

The Leelanau Conservation District contracts with the county Board of Commissioners to provide some of the services. It operates a small retail store from its office which features local agricultural products, nature books and animal deterrents. Fees are collected for some of the site visits by staff members. Grants from the Michigan Dept. of Agriculture have provided a small operations fund and paid for the staff forester.

As of this writing, the funding from MDA has been eliminated for F.Y. 2008, which begins October 1. The District must try to increase its retail sales, apply additional service fees, and institute a direct mail campaign to make up the \$75,000 shortfall.

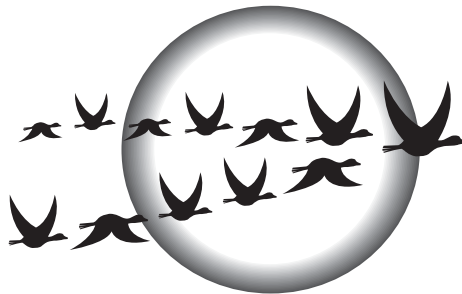
